

## **Senneca Enclose the Kitchen 2026 Contest Rules and Regulations**

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** This Sweepstakes is open only to those who participate and who are eighteen of age or older as of the date of entry. The Sweepstakes is only open to legal residents of United States and is void where prohibited by law. Employees of Senneca and immediate family members and/or those living in the same household of Employees are not eligible to participate in the sweepstakes. The Sweepstakes is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
